Ms. Sugarman,

I am writing in regard to Mr. Anthony A. Piccirillo failing to file the following 2019 financial disclosure reports: JANUARY PERIODIC REPORT, 32 DAY PRE PRIMARY REPORT, 11 DAY PRE PRIMARY REPORT, 10 DAY POST PRIMARY REPORT, JULY PERIODIC REPORT.

As you can see from the attached documents, Mr. Piccirillo has clearly been campaigning since the beginning of 2019. Yet he has failed to file a single financial disclosure statement.

During this time, he has held fundraisers, paid for and distributed mailers and literature and solicited funds through his Facebook page, www.facebook.com/anthonypiccirillo/.

As you know, under NYS Election Law 14-104(1), it is the obligation of a candidate to disclose all the receipts and expenditures of their campaigns. Additionally, pursuant to Election Law 14-118, each political committee must also have a treasurer and an identified depository. The treasurer and depository are required to keep detailed records of all receipts, transfers, loans, liabilities, contributions, and expenditures made by a candidate's campaign committee.

The voters of the 8th district deserve to see the receipts and expenditures of Mr. Piccirillo. As such, I respectfully request that your office take the necessary steps to require Mr. Piccirillo to comply with the election law. I believe he is presently in violation of Election Law 14-126 based upon his willful failure to comply with the New York State Election Law.

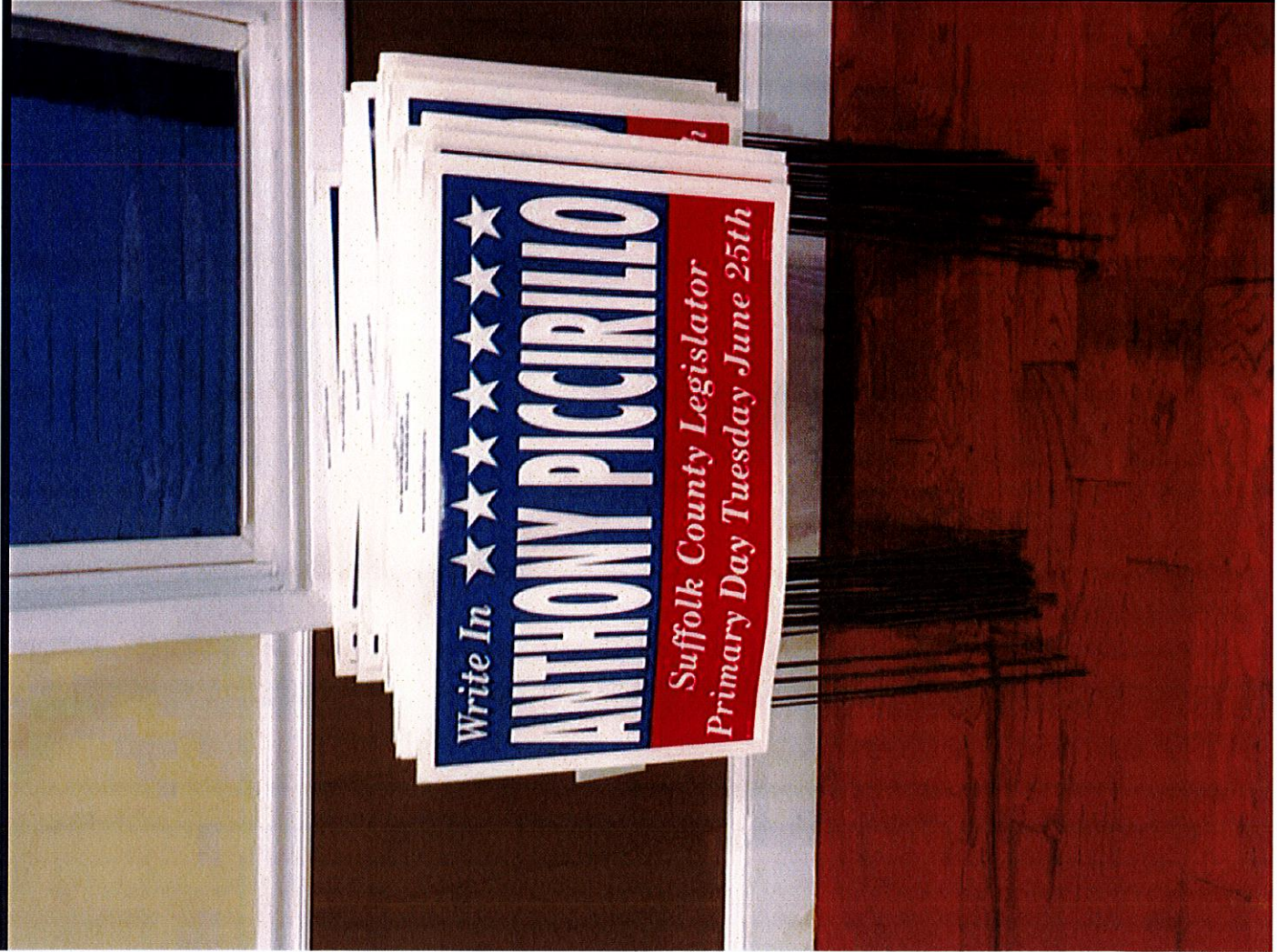
